4 DECLARATION

► I declare that:

- The corporation is not in default in filing annual returns or notices under The Non-profit Corporations Act, 2022.
- A notice of meeting of members, in accordance with subsection 14-17(3) of the Act, was sent to each member stating that a dissenting member is entitled to be paid the fair value of the member's membership interest in accordance with section 14-19 of the Act.
