



**SPPR/JR Search
Reference Sheet effective
February 5, 2018**



Introduction

Beginning February 5, 2018, search results in the Saskatchewan Personal Property Registry (SPPR) and Judgment Registry (JR) will display active enforcement instructions registered against judgments. Including these notices into the SPPR and JR will provide quick and convenient access to this information.

On February 5, all newly received enforcement instructions delivered to the local Sheriff will be registered by the Enforcement of Money Judgments Unit against judgments in the registry. At that time, all current enforcement instructions filed with Sheriff Offices will have been imported into the SPPR and JR.

An enforcement instruction is a part of the legal process in place that enables the Sheriff to pursue funds owed under a judgment. Enforcement Instructions to enforce a judgment can be provided to the local Sheriff after a judgment has been registered in the Judgment Registry. Benefits of this change in the SPPR and JR search include:

- Any search of a debtor name, the judgment or enforcement instruction will indicate the existence of an active enforcement instruction
- Enforcement instructions will be a separate registration, but linked to the related judgment. This will allow for enforcements instructions to amended or discharged without impact to the judgment.
- Enforcement instruction details will include important information like the registration and expiry dates, creditor's representative in addition to the judgment details like the debtor and creditor parties.
- Ability to search on linked registration number, retrieving details on both the judgment or enforcement instruction.
- Registration types will now be displayed on Step 3 of a SPPR search providing details on the type of agreement (i.e. Security Agreement, Sale of Goods, and Judgment).

Enforcement Instruction

As of February 5, 2018 all newly received enforcement instructions delivered to the local Sheriff will be registered by the Enforcement of Money Judgments Unit against judgments in SPPR.

- A conversion activity will take place transferring all active enforcement instruction registered with the local Sheriff or the Enforcement of Money Judgment unit into the SPPR.
- The Enforcement of Money Judgment unit will register (setup, amendments and discharges) enforcement instructions received in local Sheriff office into the SPPR.
- All enforcement instruction registration must be linked to an active judgment and will be registered for a 2-year period that can be renewed prior to expiry.
- Enforcement Instruction registrations do not carry onto a title but will be visible through a SPPR or JR search.
- There can only be one enforcement instruction registered against a judgment creating a link between the judgment and enforcement instruction. Searching either registration numbers will bring back the linked results (judgment followed by enforcement instruction).
- If a judgment is linked to an enforcement instruction, prior to discharging the judgment the enforcement instruction must be release by the creditor's representative.

Enforcement Charge - Provincial Judgment

- The registration type will be displayed advising of the type of agreement.
- Hoover over displaying the full registration type name.
- If an enforcement instruction is linked to the judgment, it will be displayed with a Yes and the registration # of the enforcement instruction will be indicated.
- Enforcement Instruction (if linked) will be displayed on the detail search result with the judgment information first followed by the enforcement instruction.
- Ability to search the registry with either registration number obtaining the details of the judgment and enforcement instruction.
